Country Specific Notes

Global:

Individual tax rules/entitlements are different per country and could result in tax deductions on monthly payslips in accordance with local tax regulations. See FAQs on the final page of this document.

Australia:

Australia does not recognize Allianz as a local plan and therefore, if you are covered under Allianz health insurance, you may be subject to Lifetime Health Cover (LHC) loading. LHC loading is a government-imposed penalty that applies to individuals who do not maintain continuous private hospital cover after the age of 31 which may lead to higher premiums in the future.

If you wish to avoid these additional charges, you may consider obtaining personal hospital coverage instead.

Bulgaria:

Payroll deductions require a wet ink signature from the employee. If the employee adds dependents, clients must cover the cost of dependents until the signature is obtained.

Netherlands:

Offering Allianz is considered a top up plan only and does not satisfy the national insurance requirements. Employees should obtain their own individual local policy in compliance with the national requirements.

3 Plan Details

Enrollment process

You will receive an invitation from ThanksBen to enroll within 48 hours of the benefit offering or when your contract becomes active

You have 30 days from your eligibility date to complete the enrollment process, which includes adding your dependents or opting out of the coverage

If you do not complete the enrollment process within this timeframe, you will be auto-enrolled into the offered benefit

You will receive a welcome email from Allianz with your plan details, as well as instructions for the Employee Portal and App

Note: Your enrollment status on the Deel platform will be updated each month following the 5th of the month

Coverage dates

Coverage is the first of the month. If you complete your enrollment between the 1st and 15th of any month, your coverage will be backdated to the first of that month. If you complete your enrollment between the 15th and 30th/31st of any month, your coverage will be effective the first of the following month

Coverage will end the last day of their employment month.
